The UU Church in Eugene Did More Than Create a Land Acknowledgment Statement

A few members of the UU Church in Eugene who were involved in the creation of the Land Acknowledgement statement read quarterly at the Sunday service formed an Indigenous Connections Circle (ICC), Some ICC members have tribal affiliations, and some do not. One month, ICC decided to host a lunch to raise money for the Chinuk Wawa Scholarship Fund at Lane Community College. Chinuk Wawa is a contact language once spoken across the Pacific Northwest. Like many Indigenous languages, Chinuk Wawa lost many speakers during the 20th Century, and is now being revitalized. ICC's language program was developed in collaboration with the Confederated Tribes of Grand Ronde.

ICC chose to support this program because of its proximity to the church and because of a need that is not being met elsewhere. The cost of tuition is often an obstacle for people who would like to enroll. ICC would like to make Chinuk Wawa available to more people.

ICC provided Lunch for Language at the church on a Sunday in May. An information table displayed materials written in
